- 3. These Share Units were acquired through compensation deferral.
- 4. This amended Form 4 is being filed to correct the number of Share Units acquired by the reporting person through compensation deferral and to correct the resulting number of Share Units beneficially owned by the reporting person following such acquisition.
- 5. These Share Units do not become exercisable or expire on a fixed date. (Generally, the Share Units become payable at the time the reporting person ceases to be a Director of the Issuer.)
